

Privacy Policy

This Privacy Policy explains how Pulsed LLC ("Pulsed," "we," "us," or "our") collects, uses, stores, and protects information when you use PulsedPredict, our website (pulsedpredict.ai), and our mobile application (collectively, the "Service"). This Policy applies to both the website and the app. By using the Service, you agree to the practices described here.

1. Information We Collect

Account Information

When you sign in, we use Magic.link, a passwordless authentication provider, which requires only your email address. We do not collect or store passwords.

Query and Usage Data

We store the prediction questions you submit, the AI-generated responses returned by PulsedPrism™, and related usage activity (such as which predictions you view or track), so the Service can function and so we can improve PulsedPrism™ accuracy over time.

Device and Log Data

Like most online services, we automatically collect limited technical data such as IP address, browser or device type, and access timestamps, for security and diagnostic purposes.

Payment Information

PulsedPredict does not currently process payments; the Service is offered free of charge. If paid tiers are introduced in the future, payment processing will be handled by a third-party payment processor (such as Stripe), and Pulsed LLC will not directly store your full payment card details.

2. How We Use Information

We use the information described above to: operate and maintain the Service; generate and improve PulsedPrism™ predictions; authenticate your account via Magic.link; respond to support requests sent to support@pulsed.me; monitor for misuse, errors, or security issues; and comply with legal obligations.

We do not sell your personal information to third parties.

3. Third-Party Services

The Service relies on the following third-party providers, each of which processes limited data on our behalf:

- **Magic.link** — passwordless authentication (processes your email address)
- **Anthropic API** — powers PulsedPrism™ AI synthesis (processes your submitted queries)

- **Google Workspace** — business email infrastructure
- **SendGrid** — transactional email delivery
- **Wix** — website hosting

4. Data Storage and Retention

Your query history and account data are retained for as long as your account remains active, or as needed to provide the Service and improve PulsedPrism™ accuracy. You may request deletion of your data at any time by contacting support@pulsed.me.

5. Your Privacy Rights

If You Are in the European Economic Area (GDPR)

You have the right to access, correct, delete, or export your personal data, and to object to or restrict certain processing. To exercise any of these rights, contact support@pulsed.me.

If You Are a California Resident (CCPA)

You have the right to know what personal information we collect, to request deletion of that information, and to not be discriminated against for exercising these rights. We do not sell personal information, so there is no sale to opt out of. To exercise these rights, contact support@pulsed.me.

All Users

Regardless of location, you may request a copy of your data or request that we delete it by emailing support@pulsed.me. We will respond within a reasonable time.

6. Data Security

We use reasonable administrative and technical safeguards to protect your information. No method of transmission or storage is completely secure, and we cannot guarantee absolute security.

7. Children's Privacy

The Service is not directed at children under 18, and we do not knowingly collect personal information from children. If you believe a child has provided us with personal information, contact support@pulsed.me and we will delete it.

8. International Data Transfers

Pulsed LLC is based in the United States, and our third-party service providers may process data in the United States or other countries. By using the Service, you consent to the transfer of your information to these locations.
